Emily Alison: Currently works as a research associate at the University of Liverpool, who jointly developed the ORBIT framework for Advanced High Value Detainee Interviewing. She has observed over 800 hours of U.K. police interviews with terrorists, covering a range of ideologies including: Al Qaeda, Right-Wing, and ISIS.

Jim Smyth: Over 30 years of experience as a major crime investigator, forensic interviewer, and criminal profiler with the Ontario Provincial Police, commanding operations in Central Ontario. He is an exceptional police leader with extensive international experience providing quality law enforcement instruction.

Aldert Vrij: In 1991, he received his Ph.D. from Vrije Universiteit in Amsterdam and currently is the Professor of Applied Social Psychology. He has produced more than 600 publications and more than 25,000 citations. He is the author of Detecting Lies and Deceit: Pitfalls and Opportunities which is a comprehensive overview of research into (non)verbal and physiological deception and lie detection.
